### Chapter 1: Political Foundation and Integration with Civilization (The Software System)

#### Article 1: Ending Illegal Tyranny and Rebuilding Constitutional Order

[Policy Content]:

##### 1. Designating the Fake Regime and Returning Sovereignty:

- **Legal Definition:** Under the Magna Carta of Chinese Freedom, the Chinese Communist Party (CCP) regime is officially classified as an "**Unconstitutional State-Stealing Syndicate**" because it never received the free electoral authorization of the people. All institutions built by it are an "**Illegal Fake Regime.**"
- **Returning Sovereignty:** The new government's mission is to "end the chaos and restore civil rights." We instantly strip this criminal syndicate of all illegal control over the state machine and return the public power to the lawful institutions authorized by the Constitution.

##### 2. Banning Unconstitutional Organizations and Liquidating Illegal Assets:

- **Ban Order:** The CCP and all its branches (including the Youth League, Women's Federation, official labor unions) are declared "**Unconstitutional Rebel Organizations**" and "**Criminal Syndicates.**" Effective immediately, they are ordered to disband and stop all activities.
- **Treasury Recovery:** Seize and freeze all assets under these organizations (including party assets and the private wealth of the elites). After an independent audit, they will be classified as "**Predatory Assets,**" confiscated in full, and injected into a National Compensation Fund to pay back the citizens persecuted for decades.

##### 3. Administrative Neutrality and "Limited Amnesty":

- **De-communization:** Abolish all "**full-time political posts**" (like Party Committees, Political Commissars, Discipline Committees) in government agencies, the military, and public institutions that have nothing to do with actual work. Stop their salaries immediately.
- **Conditional Amnesty: \* Punishing Blood Debts:** Anyone involved in crimes against humanity, torture, or directly causing the death of citizens (having blood on their hands) will be handed over to the courts. Zero mercy.
  - **Corruption Amnesty (The Redemption Clause):** Because corruption was baked into the old system, we offer a "**Conditional Amnesty**" for economic crimes with no blood involved. Officials who surrender all their illegal money (into the Corruption Fund) within a strict deadline will not go to jail. They can even keep their jobs if they swear loyalty to the new Constitution. Those who hide or move their money will be crushed by the law.

##### 4. Uprooting the Economic Base of Privilege:

- **Abolish Monopolies:** Abolish "public ownership," which was just an excuse for political privilege. Begin the lawful privatization of state assets.

- **Wealth to the People:** Establish the iron rule that **"Private property is sacred and inviolable."** Any attempt by the state to rob or infringe upon private property is a severe constitutional crime.

#### 5. Wiping Out Personality Cults and Brainwashing:

- **Cleaning Public Spaces:** Legally tear down and remove all statues, slogans, and monuments symbolizing totalitarian rule and personality cults nationwide.
- **Education Returns to Common Sense:** It is strictly forbidden to use taxpayer money to force-feed a single ideology in schools and the media. Education and news must return to objective neutrality.

#### 6. Defending the Constitution and Anti-Rebellion:

- **Defining Rebellion:** Let it be known: Any organized attempt to use violence to stop democracy, fight the new Constitution, or bring back the dictatorship is no longer "political expression." It is **"Armed Rebellion"** and **"Endangering National Security."**
- **Resolute Enforcement:** The federal government authorizes the military and police to fulfill their **"Duty to Defend the Republic."** Any armed rebellion will be crushed with an iron fist. Zero tolerance for any violent attempt to overthrow constitutional democracy.

**[Legislative Goal]:** End the disaster of dictatorship with the rule of law. Replace violent revenge with righteous trials. Cut out the cancer of autocracy while establishing the ultimate supremacy of the Constitution. **[Expected Effect]:** The party-state system is permanently destroyed. China peacefully and smoothly transitions into a normal, modern nation governed by the rule of law, winning the love of its people and the respect of the world.

### Article 2: Political Freedom, Election Revolution, and Defensive Democracy

#### [Policy Content]:

#### 1. Absolute Freedom to Run for Office (Zero Barriers):

- **Registration, Not Approval:** Abolish all government "approvals" needed to form a political party. We use a **"Filing System."** Any citizen group, even if it's just one person, can automatically become a legal political party just by filing their platform, as long as they respect the Constitution.
- **Equal Rights for Independent Candidates:** The Constitution protects the **"Individual's Right to Run."** Any citizen of age can run for President, Congress, or Mayor as an **"Independent Candidate"** without joining any party.
- **Equal Treatment:** Independent candidates get exactly the same TV time, ballot placement, and vote-monitoring rights as big political parties.

#### 2. Ultra-Simplified Legislatures (No Feeding Lazy Politicians):

- **Mandatory One-Chamber System:** Provinces, cities, and counties **MUST** use a **"Unicameral" (one-chamber)** council. Local governments are completely banned from setting up "two chambers" just to invent fake jobs and waste taxpayer money.
- **Part-Time Councilors:** City and county councilors will work part-time (paid per meeting, not a full salary). We want real citizens with real jobs running the community, not professional politicians.

#### 3. Anti-Corruption in Elections and Massive Bounties (Bankrupting Vote Buyers):

- **The "Whistleblower Get-Rich Plan":**
  - **Everyone is a Spy:** We set up an **"Unlimited Bounty Mechanism"** against

vote-buying. Any voter, staff member, or rival who proves a candidate bought votes, gave gifts, or promised jobs will get paid:

- **Guaranteed Reward:** At least 500,000 Federal Yuan in cash (paid upfront by the state, absolutely anonymous).
- **A Cut of the Loot:** The whistleblower gets an extra 30% to 50% of the ENTIRE confiscated wealth of that corrupt politician and his family. No upper limit!
- **Legalized Entrapment:** It is completely legal for voters to "pretend to accept the bribe, record it, and report it later." Taking the money, not doing the favor, and ratting them out is not a crime—it makes you a hero.
- **"Lifetime Ban" and Family Asset Seizure:**
  - If anyone on a candidate's team (including volunteers and donors) buys votes, the candidate is instantly disqualified and **banned for life** from holding public office.
  - **Punitive Economic Ruin:** Vote buyers don't just go to jail. Every single asset owned by them and their immediate family is completely confiscated.

#### 4. Absolute Purity of Election Organizers (Who Watches the Watchers?):

- **The Independent Electoral Commission (IEC) – The Fourth Power:** Totally independent of the President, Congress, and Courts. Its budget is hardwired into the Constitution (1% of the budget). The Treasury cannot freeze its money; the President cannot give it orders.
- **Jury-Style Election Workers (Random Draw):**
  - **No "Career Election Officials":** The people managing polling stations and counting votes are NOT bureaucrats. They are randomly drafted via blockchain from local, crime-free ordinary citizens.
  - **Use and Replace:** A citizen can only serve as an election worker once every 10 years. Constant turnover physically destroys any chance of building bribery networks.

#### 5. Internal Whistleblowing and Draconian Punishments (Making the Referees Afraid to Cheat):

- **Internal Takedown Mechanism:**
  - **Double Bounties:** A special "Traitor Reward" for IEC staff. If you rat out a coworker or boss trying to alter data or take bribes, you get DOUBLE the bounty (at least 1 Million Yuan) and instant witness protection/immigration if needed. *The logic: Anyone thinking about taking a bribe must constantly fear that their coworker will happily sell them out for a million bucks.*
- **Defined as Treason:**
  - **Maximum Deterrence:** Using public office to rig an election is not simple corruption; it is "**Subversion of State Sovereignty**" and "**Treason.**"
  - **The Consequence:** It carries life in prison or the death penalty. The President is constitutionally banned from ever pardoning election riggers.

#### 6. Full-Process Transparency (Physical & Digital Double Locks):

- **Banknote-Level Security:** Paper ballots are printed with the same anti-counterfeit tech as paper money.
- **Global Live Stream:** Counting centers broadcast 24/7.

- **Blockchain Proof:** Every single scanned ballot is instantly uploaded to the blockchain. Any hacker in the world can verify the data.

**[Legislative Goal]:** Use sky-high bounties to smash the unwritten rule of "taking money to do favors." Make sure vote buyers can't find a single person in this country brave enough to take their dirty money. **[Expected Effect]:** Chinese elections will be the cleanest on earth. Buying votes will become the most dangerous job in the world. Ordinary people will earn real wealth simply by defending democracy.

### **Article 3: Bilingual Nation and the State Operating System Upgrade (The Bridge to the World)**

**[Policy Content]:**

#### **1. Legalizing Official Languages:**

- The Constitution officially confirms that **English** and **Chinese (Mandarin)** are the official languages of the Chinese Federation, possessing exactly the same legal power.
- All federal laws, presidential executive orders, court rulings, business contracts, and government documents must have both Chinese and English versions, and both are equally binding.
- Any citizen or foreign investor has the right to demand zero-barrier, full-English service when dealing with government agencies (tax, police, business registration).

#### **2. Education System Reboot (Immersion Strategy):**

- **50/50 Immersion:** Launch the national "Language Melting Pot Plan." From kindergarten to high school, public education runs on a "**50% Chinese + 50% English**" model. English is no longer a "foreign language class"; it is the "working language" used to learn math, science, and coding.
- **Importing Global Teachers:** Within the next 10 years, use high salaries and green cards to import 1 million native English-speaking teachers globally, ensuring even village kids get pure English education.

#### **3. Thresholds for Civil Servants:**

- After a 5-year grace period, all frontline federal civil servants and judicial officers must pass bilingual certification. Those who cannot adapt will be transferred or fired.

**[Strategic Definition and National Dividends]:** **1. Economic Dividend:** Language barriers are the biggest hidden tax in global trade. When China becomes an English-speaking country, multinationals won't need massive translation teams. Wall Street, London, and Singapore can seamlessly move their hubs to Shanghai or Shenzhen. We upgrade from being the "World's Factory" (selling sweat) to the "**World's Office**" (selling brains and service). **2. Information Dividend:** 95% of the world's top academic papers, open-source code, and tech docs are in English. Bilingualism tears down the "Information Berlin Wall." Chinese scientists and students won't have to wait for translations; they will sync with the global brain in milliseconds. **3. Cultural Dividend:** English is the key to the free world. Mastering it means citizens can read international media directly, and the dictatorship's brainwashing automatically goes bankrupt. Only by knowing the world's language can we tell the world about Chinese culture. **[Expected Effect]:** Within 15 years, China will have the largest pool of English-speaking talent on earth. Multinationals will place R&D centers in every Chinese city. The Chinese people will confidently become global leaders.

### **Article 4: Freedom of the Press, Internet Liberation, and Privatizing the Media**

## (Establishing the Fourth Estate)

### [Policy Content]:

#### 1. Freedom of Speech and Digital Human Rights:

- **Tear Down the Firewall (Physical Disconnect):** Issue Executive Order No. 1 to immediately sever all physical cables and logic nodes of the Great Firewall (GFW). Declare that "freely accessing the global internet and freely obtaining information" is a sacred, inviolable digital human right.
- **Decriminalize Speech (Criminal Immunity):**
  - **Abolish "Speech Crimes":** Instantly wipe out garbage laws like "Inciting subversion of state power" or "Picking quarrels and provoking trouble."
  - **Absolute Immunity:** Citizens have absolute criminal immunity to criticize the government, curse officials, or discuss sensitive politics. No cop can arrest anyone for an internet post.

#### 2. Privatizing Media and Protecting Journalists (The Fourth Estate):

- **Open Media Licenses:** Completely abolish the Propaganda Department. Any citizen or private company can start a newspaper, radio station, TV network, or website.
- **Journalist Privilege Law:** Professional reporters and "**Citizen Journalists**" (bloggers/YouTubers) have the legal right to refuse to reveal anonymous sources to the courts or police, protecting whistleblowers.
- **Right to Record:** It is a legal right to film police and government officials in public. Cops are strictly forbidden from stopping cameras, deleting videos, or seizing phones.

#### 3. Governing Rumors and Boundaries (The Sullivan Principle):

- **Civil, Not Criminal:** The government (police) cannot arrest people for fake news or rumors. Victims (people or companies) can only file civil lawsuits in court for money and apologies.
- **The "Actual Malice" Rule:** We draw a hard line between "criticism" and "defamation":
  - **For Politicians/Officials:** Officials must tolerate harsh criticism and even some false accusations. Unless the official can prove the media "**knew it was a lie but spread it intentionally to destroy them**" (Actual Malice), the court will throw out the defamation lawsuit.
  - **For Ordinary Citizens:** Strict privacy protection. If the media maliciously spreads rumors to hurt a regular person, they face ruinous, sky-high financial payouts.
- **Truth is the Absolute Defense:** As long as the report is true, even if it destroys someone's reputation, there is zero legal liability.

#### 4. Wiping Out Official Mouthpieces and Cutting the Cord:

- **Stop the Funding:** Instantly cut off all taxpayer money to official state media (Xinhua, People's Daily, CCTV, local party papers) and disband them.
- **Wipe Out Privileged Groups:**
  - **Disband Military Troupes:** Unconditionally disband all military and government singing, dancing, and sports troupes. Strip them of their military ranks; let them make a living on the free market.
  - **Disband "Official Associations":** Disband state-sponsored writers' and journalists' associations. Stop all funding.

- **Ban Government-Owned Media:** Government agencies are strictly forbidden from owning or running commercial news media to stop them from secretly manipulating public opinion.

## 5. Digital Anti-Monopoly and the Iron Rule of Algorithm Neutrality (Breaking the Black Box):

- **Platforms are "Public Utilities":** Any app (social, news, short video) with over 10 million daily active users is legally defined as "**Digital Public Infrastructure.**" They are no longer private playgrounds; they must obey "Algorithm Neutrality."
- **Algorithm Audits:** All major platforms must register their core recommendation logic and trending mechanics with the "Federal Digital Oversight Commission." The watchdog has "**Penetrating Audit Rights**" to spot-check the code anytime to ensure they aren't secretly silencing certain views.
- **Smashing the "Filter Bubble":** Platforms are banned from feeding users only what they want to see to make them extreme. The law forces feeds to include 20% random or diverse information. Manipulating algorithms to incite hate or populist panic is punished as "**Endangering Public Security.**"
- **The "Turn Off Algorithm" Button:** All platforms **MUST** have an obvious button to "Turn Off Algorithm Recommendations." Users have the right to view feeds in purely chronological order and refuse to be force-fed by a machine.

**[Legislative Goal]:** Give people back their eyes and mouths. Let the truth flow freely. Use "civil payouts" instead of "police arrests" to handle rumors so the government can't use "fake news" as an excuse to shut people up. Stop wasting taxpayer money on people who only sing praises to the state. **[Expected Effect]:** A spectacular explosion of free media. Government lies will have nowhere to hide. Historical freaks like "military singing troupes" will vanish forever. Rumor-mongers will face bankruptcy, not jail time. A society of trust will be rebuilt in freedom.

## Chapter 2: The State Machine and Rebuilding the Rule of Law

### Article 5: Nationalizing the Military and Civilian Control

#### [Policy Content]:

- **Nationalization of the Military:** The Federal Defense Force (formerly the PLA) must strip away all political party affiliations. The entire military will take an "Oath to the Constitution." They answer **ONLY** to the country and the Constitution, never to any political party or individual.
- **Civilian Control Principle:** The Ministry of Defense is the supreme military administrative body, and the Secretary of Defense **MUST** be a civilian with no military rank. The ultimate command of the armed forces belongs to the elected President and Congress. Active-duty soldiers are strictly forbidden from interfering in political decisions.
- **Ban on Domestic Deployment (The Constitutional Iron Cage):** The **ONLY** job of the Federal Defense Force is to defend against foreign invasions. **It is strictly forbidden under any circumstances for the military to intervene in domestic policing, crush protests, or take military action against its own citizens.** Any commander who orders troops to shoot citizens, and any soldier who pulls the trigger, will be charged with "Crimes Against Humanity." There is no statute of limitations, and they will be hunted globally.

- **Treating Professional Soldiers Right:** We strictly separate professional military officers from political commissars. All non-political, professional officers and soldiers will keep their jobs. We will raise their salaries, housing allowances, and retirement benefits, making them the hardcore defenders of the new Constitution.
- **Abolishing Art Troupes and Privileges:** Instantly disband all military singing, dancing, and sports troupes. Strip them of their military ranks and send them back to the commercial entertainment market.

**[Legislative Goal]:** Turn the "Party's SS" into a true "National Defense Force." Lock the "stability maintenance machine" in an iron cage and completely uproot the possibility of the military violently suppressing the people. **[Expected Effect]:** The military goes back to defending the nation. The soil for military coups and warlords is completely destroyed.

## **Article 6: The Justice Revolution (Common Law, Decentralized AI Courts, and Transparent Policing)**

**[Policy Content]:**

### **1. The Foundation of Justice: Return to "Common Sense and Conscience":**

- **Establish Common Law:** Abolish the obscure written legal codes that are easily manipulated by bureaucrats. Declare Common Law, based on "**Precedent**" (Binding case law), as the cornerstone of federal justice.
- **The Masses' Conscience > Elites:** The power to interpret the law no longer belongs to elites or powerful politicians; it belongs to the universal conscience of ordinary people. We firmly believe: For thousands of years, the calculations of the elite have often been the accomplices of dictators and the root of corruption. Only the raw, honest sense of justice of ordinary people is the last defense line for social fairness.

### **2. Trial Mechanisms: Juries and Decentralized AI Juries (Double Randomness and the Circuit Breaker):**

- **The Physical Jury (12 people):** Drawn entirely at random from a pool of bottom-rung citizens with no criminal records. They sit physically isolated (double-blind) in the courtroom to deeply review the micro-facts and evidence chain.
- **Massive Cloud Jury (1000+ people):** Using blockchain technology, the system randomly selects over a thousand citizens nationwide. After ID verification, they vote independently on the case online. The law of large numbers completely dilutes and blocks any form of bribery or power interference.
- **Judicial Circuit Breaker & Super Precedent (National Referendum):**
  - **Trigger Mechanism:** If the "Physical Jury" and the "Cloud Vote" clash completely (implying corruption or elite manipulation), it instantly triggers the "**Judicial Circuit Breaker.**"
  - **National Referendum:** The case is thrown directly to the entire nation for a vote. Because the result of this referendum will deeply bind every voter today and all future generations (every single Chinese person), this shared fate will force everyone to cast a just and fair vote. This guarantees absolute justice and creates a new social contract. The referendum result is the final verdict and automatically becomes a "**Super Precedent**" with supreme legal power.

### **3. Algorithmic Sovereignty and Absolute Sunshine (Preventing Tech Totalitarianism):**

- **The Open-Source Iron Rule:** The Constitution dictates that any algorithm running

public power (including jury draws, vote counting, tax math, and welfare dividends) MUST have its source code unconditionally open to the world.

- **Global Audit:** Establish massive "Algorithm Bounties" to encourage hackers and computer experts worldwide to find bugs. Anyone caught trying to plant a backdoor in the code commits a "**Crime Against Humanity.**"
- **The Analog Backstop:** Reject blind faith in tech.
  - **Paper Backups:** All electronic votes, court verdicts, and property deeds must have physical paper backups.
  - **Disaster Recovery:** If the electronic system is hacked or crashes, the paper files are the ultimate legal proof, ensuring the state machine always stays in human hands.

#### 4. The Police Revolution: Radical Transparency and Direct Recall:

- **24/7 Live Streaming (Zero Dead Zones):**
  - **Live Meetings:** All internal admin meetings, personnel changes, case classifications, and decision-making processes inside police stations MUST be live-streamed 24/7 on the internet.
  - **Live Enforcement:** All frontline policing MUST be recorded with live-streaming body cams.
  - **Ban the Black Box:** Completely abolish the excuse of "Police Secrets." Except for extremely rare, ongoing raid tactics, any attempt to cut the live feed or operate in the dark using "secrecy" as an excuse is legally defined as a "**Premeditated Crime.**" The cop is instantly suspended and put on trial.
- **Citizens' Direct Right to Recall:**
  - **Community Assessment:** Police no longer answer to superiors; they answer to the neighborhood residents.
  - **Instant Firing:** Residents have a one-click "**Police Recall Procedure.**" If a cop or police chief gets enough "no-confidence" votes from locals, they are instantly fired and stripped of their badge—no approval from superiors needed.
- **Independent Oversight Commission:** Establish an "Independent Police Oversight Commission" made ENTIRELY of non-government civilians. They have the supreme power to investigate and sue the police, ending the mafia-like "cops investigating cops" protection racket.

**[Legislative Goal]:** Rebuild trust: Believe that "the conscience of the people" beats "the arrogance of officials." Uproot tyranny: Use "24/7 Livestreams" and "Direct Firing" to turn the police from "thugs of the rulers" back into "security guards for the neighborhood." Tech empowerment: Use the internet to turn every pair of eyes into a searchlight watching justice.

**[Expected Effect]:** Collusion between cops and criminals, torture, and backroom deals will vanish because their physical environment is destroyed. China will build the cleanest, most transparent, and most trusted justice system in human history.

#### Article 7: Ultra-Simplified Government, Banning State Luxury, and the Anti-Corruption Bounty Act

**[Policy Content]:**

##### 1. Decentralization and Unplugging (Building an Ultra-Small Government):

- **City/County Autonomy:** Make city and county governments the core of public service. Real power—police, education, healthcare, business administration—is pushed completely down to the city/county level.
- **Look Down, Not Up:** Mayors only answer to local voters and the city council. If the federal or provincial government gives an order that hurts local interests, the mayor has a constitutional duty to refuse it (Right to Executive Disobedience).
- **Mass Layoffs and Abolishing Agencies (The Negative List):** Build the world's most streamlined government (Small Government Model). Immediately and unconditionally abolish: The Family Planning Office, Cyberspace Administration, Development and Reform Commission (NDRC), Petition Bureau, Radio & TV Administration, the brutal Urban Management (Chengguan), and all Party Committee offices. **Cut the total number of government employees by 80%.**
- **Full AI Administration:** Introduce a national AI government system to replace inefficient, rent-seeking human approvals. Except for crucial major decisions, all daily admin tasks (licenses, tax filing) are handled fairly by AI algorithms, ending the era of "hard to enter, ugly faces, hard to get things done."

## 2. Banning the "Three Public Consumptions" and Anti-Waste Mechanisms:

- **Car Reform:** Except for police, fire, ambulance, and emergency repair vehicles, completely abolish all standard government cars. Ordinary bureaucrats and officials must pay for their own commute or take the bus.
- **Core Security Exception:** Only the President, Cabinet Ministers, and key posts specially approved by Congress get armored cars and bodyguards, ensuring the state's brain stays safe and commands flow during crises.
- **Ban on State-Funded Dining and Tourism:** State-funded banquets are strictly banned. Official hosting means a "working boxed lunch" (paid out of pocket or with a ridiculously low budget). Violators are charged with embezzlement. Using "study tours" as an excuse for state-funded vacations is strictly banned. Unnecessary international exchanges must be done via video call.
- **Wasting Public Funds is a Crime:** Set up the "Crime of Squandering Public Funds." Buying luxury office supplies or building lavish government buildings leads straight to criminal charges for the agency head.

## 3. The Sunshine Act, Universal Bounty, and Whistleblower Absolute Protection (The Ultimate Anti-Corruption Net):

- **Blockchain Finance and Unlimited Audit Rights:** Build a distributed finance system based on blockchain. Every penny the government makes (taxes, fines) and every penny it spends (down to a sheet of printer paper) MUST be uploaded to the blockchain in real-time and made public. Every citizen is granted the legal "**Unlimited Right to Audit**" government books.
- **Zero Dead Zone "Universal Anti-Corruption Bounty" (The 20% Iron Rule):** Upgrade anti-corruption from "the government fighting alone" to a "Universal Bounty Operation." Any citizen, insider, or hacker who finds proof of official corruption or waste—once verified—will receive **20% of the total recovered assets** in cash from the state. Paid directly to the first verified whistleblower, no upper limit, completely tax-free.

- **Redemption and Internal Splitting:** Use game theory to completely destroy corruption alliances. Insiders in a corrupt ring (who are not the mastermind and have no blood on their hands) who actively betray their bosses and report the crime will not only get full immunity, but they will also get the same 20% massive cash bounty.
- **Whistleblower Absolute Protection Law:**
  - **Maximum Blind Encryption:** The whistleblower's real identity gets "maximum blind encryption" by the Federal Super Digital Hub. They are kept absolutely anonymous and physically isolated from any high official during the investigation and trial.
  - **State Rebirth Asylum:** For whistleblowers in massive corruption cases, the state instantly launches a "Witness Asylum Plan." It gives them and their family new legal identities and secretly relocates them (or sends them abroad) so they can safely enjoy their new legal wealth.
  - **Revenge is Terrorism:** If any exposed official or their mafia tries to use public power or gangs to threaten or retaliate against a "whistleblower," they will be stripped of all their wealth and charged with "**Crimes Against Humanity**" or "**Terrorist Targeted Elimination.**" Zero mercy.

**[Legislative Goal]:** Build the cleanest, most efficient small government on earth. Compress the space for power through "AI approvals and mass layoffs." Plant the "Dark Forest Law" inside the bureaucracy using the "20% massive bounty and internal immunity rewards." Make corrupt officials live in extreme terror, knowing they could be sold out by their accomplices, subordinates, or the entire nation at any second. **[Expected Effect]:** Government spending will fall off a cliff, and the massive wealth saved will feed the people. Under this system, taking bribes becomes a "dead-end road with highly uncertain gains, zero trust, and constant betrayal." The unwritten rules of bureaucracy are completely destroyed by an ocean of citizen bounty hunters.

#### **Article 8: Civil Servants, Layoffs, and High Salaries to Prevent Bribery**

##### **[Policy Content]:**

- **Conditional Amnesty:** For low-to-mid-level technocrats and civil servants who committed no crimes against humanity (like direct murder, torture, or mass persecution). As long as they confess their past within a deadline, hand over their illegal money, and publicly swear loyalty to the new Constitution, they get complete immunity from criminal prosecution. They can keep their jobs or retire peacefully.
- **High Salary for Integrity:** For the elite civil servants kept after the mass layoffs, implement a "**High Salary System.**" Their income will be enough to maintain a very decent, even superior life. This solves the "don't dare to steal, don't want to steal" problem from the economic root.
- **Draconian Punishment (Zero Tolerance):** While enjoying high pay, they face "zero tolerance" for corruption. If proven to have taken a bribe (even 1 Yuan), they are instantly fired, stripped of all pensions and benefits, criminally prosecuted, and banned for life from public service.
- **Humane Transition (Soft Landing):** For the 80% redundant bureaucrats who are laid off, the state provides a 2-year "transition allowance" and free job skill training to help them enter the private sector. This prevents massive unemployment from

causing social unrest.

**[Legislative Goal]:** Divide the old system, win over technocrats, keep the state machine running, while building a lean, clean, and highly efficient civil service team. **[Expected Effect]:** Avoid administrative paralysis caused by massive purges. Achieve a smooth, peaceful transition from a corrupt bureaucratic system to a clean, service-oriented government.

### **Chapter 3: Economic Revolution and Wealth Distribution (The Engine System)**

#### **Article 9: The Land Revolution (Private Housing, Commercial Auctions, and the Survival Dividend)**

**[Policy Content]:**

##### **1. Residential and Commercial Land (Privatization and Bidding):**

- **Privatize Existing Property:** All current urban residential and commercial land is converted into absolute private property. Owners will receive a "Perpetual Land Ownership Certificate." The old "70-year lease" system is completely destroyed.
- **Auction New Land (For the Economy):** The government can no longer secretly fix prices for new industrial or commercial land. It MUST be an **"Independent Base Price + Open Global Auction."** Let global capital bid, and 100% of the money goes straight into the National Dividend Pool to maximize citizens' wealth.
- **Land Value Tax:** Implement a "Land Value Tax" on commercial and industrial land to stop billionaires from hoarding land and ensure citizens continuously share in rising land values. The tax goes straight into the Dividend Pool.

##### **2. Agricultural Farmland (National Land Bank Trust):**

- **The People's Trust:** The "nominal ownership" of all agricultural land is taken back and placed into the **"China National Land Bank,"** completely independent of the government.
- **Global Bidding:** The Land Bank will consolidate small plots into massive, modern farms and lease them to global agribusinesses via open bidding (for 30-50 years) to achieve maximum efficiency.

##### **3. Citizens' "Survival Dividend Right" (Born with it, Dies with you):**

- **Innate Land Right:** Every living citizen of the Federation, regardless of age or gender, naturally owns an unalienable right to a share of this national land rent.
- **Anti-Monopoly Rule:** This right is **"Born with it, Dies with you"**—you get it automatically when you are born, and it is canceled when you die. It is strictly forbidden to inherit, sell, or trade this right. This physically cuts off generational wealth hoarding and prevents Russian-style oligarchs from buying up the country.

##### **4. Farmer Resettlement (Voluntary Exchange):**

- **No Forced Evictions:** Farmers holding current land rights have absolute freedom of choice.
- **Cash Incentive:** Farmers can voluntarily surrender their land rights in exchange for a **"Lifelong Pension (as compensation for historical contributions) PLUS the Universal Land Dividend."**

**[Legislative Goal]:** Make "housing for the residents, profits for the plowman" a reality. Use global bidding and tax systems to continuously grow the people's wealth. **[Expected Effect]:** >

\* **Internally:** Destroy the government's addiction to selling land for its own budget. Citizens get a permanent passive income.

- **Externally:** Smash xenophobia. The logic becomes: "The more money foreign companies make here, the bigger my dividend gets." A true win-win.

## Article 10: Public Infrastructure (The Non-Profit Principle)

### [Policy Content]:

#### 1. Transportation (Completely Free):

- **Free Roads:** Declare the national highway network, state roads, and bridges as "public goods fully paid for by taxpayers."
- **Tear Down Toll Booths:** Instantly demolish every single highway toll booth and checkpoint nationwide. Any vehicle driving within the Federation pays zero tolls.
- **Merged Funding (Single Tax):** Highway maintenance is no longer funded by toll gates, but entirely merged into the "Fuel Tax" (and an "EV Mileage Tax").
- *The Logic:* "Drive more, gas up more, pay more for maintenance." It's the simplest fairness, and the administrative cost of collecting it drops to zero.

#### 2. Energy and Municipal Utilities (Free Survival Baseline):

- **Life Quota:** "Access to basic energy is a human right." Every citizen gets a legal, free monthly baseline quota of water, electricity, and internet data.
- **Tiered Pricing:** Anything used above the free quota is charged at market rates.

#### 3. Reverse Bidding and Outsourced Maintenance:

- **Outsource the Work:** Roads are free, but quality can't drop. A "National Highway Maintenance Fund" is fed by the fuel tax.
- **Bidding for Upkeep:** Global private companies bid to maintain the roads, getting paid strictly based on road quality (KPIs). If a pothole isn't fixed in 24 hours, the money is instantly deducted from the contractor!

[Legislative Goal]: Fix double taxation: If you pay gas tax, you shouldn't pay a road toll.

[Expected Effect]: Logistics speeds up massively. Physical barriers vanish, dropping China's shipping costs to the lowest in the world. Road trips are free; tourism will explode.

## Article 11: Scarce Resources and Franchises (Global Auctions and Wealth for All)

### [Policy Content]:

#### 1. Resource Sovereignty:

- **What it is:** Mines (oil, coal, rare earths), virgin forests, radio spectrums (5G/6G), flight routes, airport slots, satellite orbits, and public data are highly valuable, scarce public resources.
- **Who owns it:** These belong to ALL CITIZENS. No government agency has the right to secretly hand them out or sell them cheap to their buddies.

#### 2. Global Digital Auctions:

- **Kill Bureaucracy:** Abolish the "official approval system." Build a "National Resource Global Trading Platform." The rights to mine or operate ANY scarce resource MUST be sold here via open, anonymous, global bidding with a strict minimum price.
- **Highest Bidder Wins:** As long as they meet green and safety standards, the highest bidder gets a time-limited operating right.

#### 3. The Fiscal Firewall (Closing the Loop):

- **Smart Distribution:** The massive billions made from these auctions are **STRICTLY FORBIDDEN** from entering the government's budget to pay for administration.
- **100% Dividend:** Through blockchain smart contracts, after deducting tiny admin fees,

100% of this money goes straight into the "National Survival Dividend Pool."

- **Direct Deposit:** Combined with the land rent from Article 9, this money is deposited directly into every citizen's personal bank account every quarter!

**[Legislative Goal]:** Turn public scarcity into hard cash for the citizens. Use the free market to optimize resources while completely eradicating the power-renting and bribery in the resource sector. **[Expected Effect]:** Resources are no longer bargaining chips for corrupt officials and shady businessmen; they are the fountain of wealth for the whole nation.

## **Article 12: Restructuring State-Owned Enterprises and National Wealth Funds (Shares for All and Anti-Corruption Iron Gates)**

**[Policy Content]:**

### **1. Smash Monopoly Giants:**

- **End Monopolies:** Former state-owned giants in natural monopolies like energy (power grids, oil), telecom, railways, and airlines CANNOT be privatized as a single massive block (to prevent private monopolies).
- **Split and Restructure:** They must be physically chopped up into 3-5 independent, competing commercial entities (e.g., separating the power grid from the power plants).

### **2. Create "Competitive National Wealth Funds":**

- **Asset Transfer:** The shares of these newly split companies are not auctioned off. Instead, they are injected into 5-10 newly created "Chinese National Wealth Funds."
- **Shares for All:** The legal owners of these funds are ALL verified citizens of the Chinese Federation. The funds act as financial investors holding the shares on behalf of the people.

### **3. Direct "National Dividend" Payouts:**

- **Profits to the People:** The annual investment returns and dividends of these Wealth Funds are strictly banned from being used for government admin expenses or the federal budget.
- **Direct to Your Pocket:** Profits must go to a separate account and be distributed equally as a "National Dividend"—wired directly into the personal bank account of every single Chinese citizen every year. Everyone gets a slice of the nation's economic growth in cold, hard cash.

### **4. Sunshine Governance and Professional Managers:**

- **Cut the Cord:** Completely sever the administrative tie between the government and these companies. The board directors representing the funds MUST be globally recruited professional managers. **It is strictly forbidden for current or former government officials to work as executives in these funds or companies.**
- **Transparent Oversight:** The harshest "Sunshine Act" applies. All stock holdings, board voting records, executive salaries, and dividend data MUST be published live on the internet for the whole country to see. Citizens have the right to audit the books and fire executives in real time.

### **5. The "Golden Share" System:**

- Only in companies critical to national defense or core infrastructure (like nuclear power or backbone fiber optics) will the federal government hold a single "Golden Share."

- **Strict Limits:** This share does not participate in daily management or dividends. It ONLY acts as a veto power in extreme cases of "hostile takeovers by enemy forces" or "severe threats to national security."

**[Legislative Goal]:** Turn the abstract concept of "owned by the whole people" into real, physical "cash earned by the whole people." Break monopolies by splitting them, stop asset theft through the funds, and build a massive, consuming middle class through direct cash dividends. **[Expected Effect]:** Uproot the soil that breeds Russian-style oligarchs. Handing trillions in SOE profits directly to ordinary people every year will trigger a nuclear explosion in domestic consumption.

### **Article 13: Labor Rights Revolution and the Domestic Economy Engine (Human Rights Equal Wealth)**

**[Policy Content]:**

#### **1. Freedom of Association and the Right to Strike:**

- **Disband the Fake Union:** Immediately and unconditionally disband the "All-China Federation of Trade Unions," which is nothing but an administrative lapdog.
- **Free Unions:** The Constitution guarantees all workers (including delivery riders and Uber drivers) the absolute right to form independent labor unions in any company. Unions will act as a market force to drive up wages and force companies to upgrade their tech.
- **The Right to Strike is Sacred:** Strikes are a basic human right. Police cannot intervene in non-violent strikes.

- **Equal Pay for Equal Work (Destroy the Caste System):** Abolish the identity gap between "formal staff" and "temps/contractors." Whether in the government or private sector, if you do the same job, you get the exact same pay and benefits. Violators will be charged with the severe "Crime of Employment Discrimination."
- **Ban on Labor Dispatch (Outsourcing):** Using labor dispatch agencies just to dodge employer responsibilities is declared illegal.
- **Direct Hiring:** For any long-term core position, the company MUST sign a direct labor contract with the worker. We cut out the blood-sucking middlemen and give that profit directly to the workers.

#### **3. Gig Economy Rules: Dual-Track System and Algorithm Justice:**

- **The "ABC Test" (Substance Over Form):** For platforms like Meituan (food delivery) and Didi (ride-hailing), if a worker's dispatch, pricing, routes, and performance are controlled by the platform's algorithm, the law considers them **"Full-Time Employees."** The platform MUST pay full social security.
- **The Worker's "Dual-Track Choice":** The law forces platforms to offer two models. The WORKER chooses; the platform cannot interfere:
  - *Model A (Standard Hours):* Base pay + bonus, stable 8-hour workday.
  - *Model B (Piece-Rate/Flexible):* Paid per order; work more, earn more.
- **The Three Iron Red Lines (The Bottom Line):** No matter which model the worker chooses, the platform MUST obey these rules:
  - **Minimum Hourly Net:** Even on piece-rate, the converted hourly income can NEVER fall below the legal, decent minimum wage.

- **Full Social Security:** It is strictly forbidden to trick or force riders into registering as "independent contractors" to dodge social security.
- **Forced Rest (The Algorithm Lock):** Once a worker hits the legal maximum hours (e.g., 5 days x 8 hours + max legal overtime), the system MUST lock them out and stop giving orders to prevent fatigue driving and extreme exploitation.
- **"Obey the Law or Go Bankrupt":** We declare clearly: If a company claims "we can't make a profit if we obey labor laws," then their business model is an **"Illegal Exploitation Model."** The government encourages them to go bankrupt and leave the market. We will NEVER tolerate blood-sweat factories just for the sake of GDP or fake "tech innovation."

#### 4. The Work-Hour Revolution and a Decent Minimum Wage (Creating the Middle Class):

- **Strict 8-Hour Workday:**
  - **Ban 996:** Any forced overtime system is a crime. Only when people are freed from endless labor will they have the time to spend money, making the service industry boom.
  - **Punitive Overtime Pay:** Overtime MUST be paid at 1.5x to 3x the normal wage. Make it hurt the employer!
- **Decent Minimum Wage:** We abolish the old "barely starving" standard and establish the **"Middle-Class Entry Standard."** A full-time worker's monthly income must be enough to decently feed a family of three in their city, with money left over for savings.

#### 5. Iron Fist Enforcement: Fines on Revenue and the "Death Penalty" for Companies:

- **Reverse Burden of Proof:** In labor disputes, the employer bears 100% of the burden to prove they didn't break the law.
- **Fined Based on Revenue:** If a platform tries to find loopholes, uses the algorithm to torture drivers, or dodges taxes, they will be hit with a massive fine of **5% to 10% of their ENTIRE GROSS REVENUE** from the previous year (not just profit).
- **The Repeat Offender Kill Switch:** Any platform caught breaking labor laws for the same reason twice will instantly lose its internet operating license and business license. They are permanently banned from the market, and the founders will face criminal charges.

**[Legislative Goal]:** Turn workers from "industrial consumables" back into "human beings." By forcing high wages and strong protections, we artificially create a massive middle class with tremendous purchasing power, completely solving China's weak domestic demand.

**[Expected Effect]:** The tragedy of "riders trapped in the algorithm" ends forever. Companies are forced to actually innovate with tech instead of just squeezing human blood. China's domestic consumer market will experience a nuclear-level explosion.

#### Article 14: Sovereign Currency Reset, Wiping Out Black Money, and Global Asset Hunting (The Great Wealth Purification)

**[Policy Content]:**

##### 1. Issue the "Federal Yuan" and Forced Currency Exchange (The Corruption Filter):

- **New Currency:** Abolish the old RMB. Issue the **"Federal Yuan,"** anchored by national credit and hard assets. Set a strict, non-extendable 30-day window for legal currency exchange.

- **"Guilty Until Proven Innocent" Exchange Review (Wealth Purification):**
  - **Small Amounts Exchanged Automatically:** For ordinary citizens' bank deposits and reasonable amounts of cash (e.g., under 5x the family's annual income), exchange it 1:1 automatically, no questions asked. Protect the people's money.
  - **Big Money Audits:** Anyone holding massive piles of cash or unexplained huge bank deposits MUST provide legal tax records and prove where the money came from.
  - **Black Money to Zero (Bankrupting the Corrupt):** Any funds that cannot prove their legal origin are classified as "Illegal Proceeds." They are denied exchange and **drop to ZERO.**
  - *The Result:* The tons of cash hidden in the basements of corrupt officials' villas will become worthless scrap paper overnight.

## 2. The Economic Dividend: Deflating the Corruption Bubble, Boosting Citizens' Wealth:

- **Reversing the Dilution:** The old regime diluted ordinary people's savings by printing endless money (inflation). By refusing to exchange trillions in corrupt black money, we effectively wipe out 30%-40% of the useless money supply.
- **Wealth Appreciation:** With the nation's total assets staying the same but the amount of money shrinking massively, the purchasing power of every single new Federal Yuan will skyrocket.
- *Plainly speaking:* The corrupt officials' money is gone, so the honest citizens' money is worth much more. This is an **"Invisible Dividend"** handed out by the state to all law-abiding citizens!

## 3. Global Asset Hunting and "Start-Up Capital" for the Nation:

- **Special Recovery Order:** Establish the **"National Asset Recovery Committee"** directly under the President. Sign treaties with the US Treasury, Swiss banks, and Interpol to hunt down stolen assets.
- **Reverse Burden of Proof:** Launch a **"Global Asset Audit"** on all mid-to-high-level officials from the old regime and their families. If they hold domestic or overseas assets (including through proxies) that obviously exceed their legal salary, the government doesn't need to prove they stole it; it is automatically presumed to be corrupt money, frozen, and confiscated.

Article 15: The Soil for National Innovation

[Policy Content]:

**Ban Government Handouts (Kill Rent-Seeking):** The government is strictly forbidden from creating any "industry subsidy funds" or "special grants." We completely sever the chain where politicians and businessmen secretly hand taxpayer money to each other.

**Super Tax Write-Offs:** If a company spends its own money on R&D, it gets massive pre-tax deductions. Only companies that actually make a real profit will reap the rewards.

**Inventors Keep the Rights:** Patents invented in public research labs belong 100% to the individual inventor, not the institution or the state!

**Regulatory Sandbox (Freedom First):** For cutting-edge tech, the rule is: "If it's not explicitly banned, it's allowed." The government only steps in after the fact with a negative list.

**Failure Without Ruin:** As long as you run your business legally, you are allowed to go bankrupt without it destroying your life, your credit score, or your ability to start another business.

**[Legislative Goal]:** Completely eradicate corruption in scientific research. Make scientists and entrepreneurs the true heroes of innovation, not bureaucrats.

**[Expected Effect]:** Companies that only survive on government subsidies will die. Only companies with real blood-making abilities will survive. China becomes the global high ground for innovation.

Article 16: The Financial Revolution (Free Money, Capital Market Reset, and Harsh Punishments for Fraud)

[Policy Content]:

1. Absolute Freedom for Currency and Capital (The Global Financial Haven):

**Independent Central Bank:** Issue the new "Federal Yuan." The central bank is totally independent. Erasing government debt by simply printing money is strictly banned.

Abolish Capital Controls: Shut down the State Administration of Foreign Exchange (SAFE). Abolish all limits on citizens and businesses buying or selling foreign currency.

Money Without Borders: Capital can flow in and out of China 24/7 with zero limits and zero barriers. Any government order trying to block the flow of money is illegal!

## 2. Stock and Futures Market Revolution (Power to the Investors):

True Registration-Based IPOs: Abolish the Securities Regulatory Commission's "approval power." Companies no longer need to suck up to officials to go public; they just have to tell the absolute truth to the market. Logic: The government doesn't endorse companies; let the market decide.

Freeing Short-Sellers (The Market Police): Fully remove restrictions on short-selling. Value: Short-sellers are the "scavengers" who clean up garbage companies. Letting them make money by exposing fraud is the most effective free-market weapon against scammers.

T+0 and No Price Limits: Align with mature global markets. Allow same-day trading (T+0) and cancel artificial limits on how much a stock can go up or down in a day. Let prices reflect true value through fierce market combat.

Tax Haven for Venture Capital: Angel investments (VC/PE) get "tax deductions for losses" and "zero capital gains tax for long-term holding." This will suck global innovation capital straight into China.

## 3. Draconian Punishments for Fraud and Class Action Lawsuits:

Class Action (The Ultimate Weapon): This is the ultimate shield for retail investors. If a listed company commits fraud (even if they only lied about 1 dollar), lawyers can sue on behalf of ALL cheated investors.

Ruinous Payouts: The payout must cover 100% of the investors' losses. This often means billions, enough to instantly bankrupt the fraudulent company.

Reverse Burden of Proof: In securities fraud cases, corporate executives must prove their innocence; otherwise, they are presumed guilty.

The "Financial Death Penalty" and Infinite Liability:

For Executives: Anyone who cooks the books gets 20 years to life in prison.

Punitive Economic Stripping: Fraudulent bosses, accounting firms, and sponsors must bear "Infinite Joint Liability." Every asset owned by their entire family will be confiscated to pay back the retail investors!

#### 4. Derivatives and Futures Market (Full Sunshine):

Fully Open: Open up stock index futures, treasury bond futures, and forex options. Let businesses and people use financial tools to manage risk.

Ban Government Meddling: It is legally forbidden for the government to "pull the plug," ban selling, or issue "window guidance" when the stock market crashes. The market belongs to the market; accepting the bet and taking the loss is the core of the contract spirit.

#### 5. Financial Justice and Anti-Usury (The 12% Iron Red Line):

Interest Drops with Principal: The law demands that ALL loan interest (including installments and credit cards) MUST be calculated strictly on the "actual remaining daily principal."

Ban on Fraud: Charging interest on the full original amount for installments is banned. Charging penalty interest on the portion of a credit card that has already been paid is banned.

The 12% Hard Red Line (IRR):

The true, all-inclusive annualized interest rate (including ALL hidden fees and guarantees) for ANY loan CAN NEVER EXCEED 12%.

Debtors do not have to pay a single cent of interest above this red line. Any excess already collected MUST be paid back double!

Usury is a Crime: Anyone who uses algorithms to hide high interest rates or uses violent debt collection will be charged with the "Crime of Illegal Plunder."

#### 6. Personal Bankruptcy Protection (The Right to Rebirth for the Honest):

Legal Discharge: Establish a unified national "Personal Bankruptcy Law."

Article 17: Ultra-Simple Taxes, the Legal White List, and Absolute Taxpayer Rights

#### 1. No Taxation Without Law and Criminalizing "Fines for Revenue":

Article 18: Global Talent Magnet and Immigration Reform (Dual Citizenship and Low Taxes)  
[Policy Content]:

1. Acknowledging Dual Citizenship (Breaking the Identity Chains):

Change the Nationality Law: Completely trash the old rule that "getting a foreign passport automatically cancels your Chinese citizenship."

Welcome Home: Allow overseas Chinese to apply to keep or restore their Chinese Federation citizenship while holding onto their foreign passports.
